The Board of Directors sets the direction (Ends) and priorities for the Association, while staff members are responsible for developing and implementing the programs and services to achieve the Board's Ends/ priorities.

Membership in MAS is open to everyone. MAS provides learning opportunities for museums, personnel and their governing bodies. MAS is responsible for establishing the first Standards for Museums that now guides museum development throughout Saskatchewan.

The Association raises public awareness of museums and fosters communication among members of the museum sector. MAS represents the interests and concerns of the museum sector to decision makers including all levels of government.

To serve Saskatchewan people by advancing museums.

Saskatchewan's cultural and natural heritage will be preserved, understood and celebrated through a strong, vibrant museum community, valued and supported by society.

Wendy Fitch Executive Director The Museums Association of Saskatchewan is committed to moving continuously toward the achievement of our goals as embodied in our vision: Saskatchewan's cultural and natural heritage

is preserved, understood, celebrated, valued and supported by society. The MAS staff work hard to keep moving forward, trying new things, along with the things we know we do well to provide leadership, capacity development and a collective voice to Saskatchewan's museum sector.

During the past year MAS has embarked on three new initiatives which will have significant impacts on Saskatchewan Museums over the next several years.

First, we have begun the pilot phase for our new collections management database. This open source system will provide users with a data management system built specifically for smaller Saskatchewan museums which we will be able to provide at low cost—well under the commercial packages price point. Watch for further information on how to participate in this program later in 2016.

Second, we have entered into a partnership with SK History & Folklore Soc. & Heritage SK to develop an Intangible Cultural Heritage Initiative for Saskatchewan. At the 2015 AGM MAS revised our bylaws to include intangible, as well as, tangible cultural heritage in our definition of a museum. Activities within the ICH Initiative will be developed and offered over the next few years that will assist museums in the identification, documentation, transmission and celebration of ICH (the traditions, ceremonies, music, food, dance, etc.) which together with the tangible (the buildings, objects, landscapes, etc) are our collective cultural heritage.

Finally, what is expected to have the most transformative effect on MAS and our members is the development of our new Diversity & Inclusion Policy and Plan. Museums are no longer able to simply provide stewardship and access to collections of objects. They are expected to be places actively engaged in developing community. Museums need to be the place where we can discover who we are - to see ourselves reflected in the Board, staff, volunteers, exhibits and programs regardless of our age, gender, cultural or social identity, ability or country of origin. MAS and it's members must reach out to the community - especially those who are marginalized to ensure that they are represented within our sector. We must encourage a spirit of interculturalism within our organization and within our institutions if we are to remain relevant to the communities we serve.

As you read this annual report you will find additional evidence of how our activities, both ongoing programs & services and new initiatives are moving us toward our strategic goals and organizational ends.

I would like to take this opportunity to thank all of MAS's volunteers for their dedication over the past year. Your hard work and commitment truly make a difference in the ultimate success of the Association. I would especially like to thank the Board of Directors for their hard work and support over the past year. I have enjoyed working with all of you, and truly appreciate all the time and energy you have given to ensure the Association continues to move forward.

I would also like to take this opportunity to recognize and thank my wonderful team: Brenda, May-Lin, Ele and Dan. I truly appreciate your hard work, enthusiasm, willingness to try new things and senses of humour over the past year.

## **Community Leadership**

During 2015-2016, MAS continued to work with both internal and external stakeholders. Positive relationships with stakeholders is foundational to MAS providing leadership to museums in Saskatchewan.

The key provincial organizations MAS works with are: SaskCulture, Heritage Saskatchewan, Saskatchewan History & Folklore Society, Saskatchewan Archives Board, Saskatchewan Council of Archives and Archivists (SCAA), Saskatchewan Multitype Library Board Saskatchewan Heritage Foundation, Saskatchewan Arts Alliance (SAA), U of R's Community Research Unit and Voluntary Sector Studies Network. The working relationship MAS has established with each is valued by the Association and enhance the ability of MAS to be a leader in the museum sector in Saskatchewan. Federally, MAS works with the Canadian Museums Association, National Trust, Canadian Heritage Information Network, and the Canadian Conservation Institute. MAS also works with the 12 other provincial/territorial museums associations on matters of common interest.

MAS staff were also able to participate in a number of stakeholder events including: Community Research Unit (U of R) Showcase, Voluntary Sector Studies Network (U of R) Year-End review, CMA annual Conference, National Trust annual conference, Provincial/Territorial Association meetings, Historic Sites & Monuments Board of Canada reception, OSAC Annual Showcase, Moh Kins Tsis – Indigenous Roundtable, Firsts Nations Keepers Conference, Saskatchewan Multitype Library Board annual meeting, MCoS Multiculturalism Honors Awards, Regional Heritage Fairs and the Saskatchewan Index of Wellbeing launch.

#### **Board of Directors**

MAS is a member driven organization governed by an elected Board of Directors which governs according to the principles of policy governance. During 2015-2016, the Board met eight times including one conference call and has been diligent in ensuring it provided strategic guidance and leadership to the Association through the development and monitoring of the Global ENDs policy and the MAS strategic goals. As well, the Board continued to follow a strategy based on its selfassessment to ensure key areas are addressed. The Board has continued to focus on the relationship between itself and the membership during 2015-2016. The Member Forum at the MAS conference as well as attendance at member group meetings enabled the Board to obtain feedback on a variety of topics with members. Regular communications of Board activities through the Quarterly Reports and Board meeting summaries continued during the year.



#### Networks

Networks are regionally self-determined MAS member groups. Each Network determines its own agendas as well as its own goals and priorities. Meeting twice a year, spring and fall, Networks provide members with opportunities to: share information, ideas, and concerns; work together on projects; and acquire new skills and knowledge. Networks facilitate communications between museums within their own Network; between Networks within Saskatchewan; and between the MAS Board, staff, and Network members. Each Network's activities are co-ordinated by a volunteer Networker and are often assisted by a Co-Networker.

The number of active Networks in 2015-2016 was 11. The number of institutional members participating in the Network program last year was 132, approximately 53% of institutional members.

In 2015-2016, 18 Network volunteers gave their time; approximately 400 hours. The Networkers and Co-Networkers met as a group once in the past year. The spring meeting was held on May 21st in Regina, the evening prior to the MAS Mini-Conference and Annual General meeting.

## **Capacity Development**

This year we have continued to offer a range of high quality courses and workshops.

Program topics are based on the input received from members. This helps ensure that MAS programming is relevant and timely. Moving forward, MAS will continue to strive for member-driven programming that serves the needs of Saskatchewan's museum community.

### Certificate in Community Museum Studies Program

The Certificate Program in Community Museum Studies provides Saskatchewan's museums with affordable training in basic museum operations. It consists of ten courses, each designed to equip learners with the knowledge, skills, and standards of excellence needed to operate a successful public museum.

The courses include Museums 101, Organization and Management, Museums and the Community, Collections Management, Care of Collections, Exhibit Design and Planning, Museums and Education, Marketing the Museum, Volunteer Management, and Research. Details can be found in the Program Guide, which outlines the goals and content of the Certificate Program and each of its courses.

This year, Museums and Community and Museums 101 were offered online. As well Marketing the Museum, Care of Collections, and Museums and Education were offered in workshop format and the Research course was revised in 2015/16.

### **Governance** Program

Last year, MAS initiated a new governance support program, which uses independent modules on governance-related topics, allowing for the provision of governance support in the areas most relevant to each museum board's needs. Each module takes roughly two hours to deliver, making them more practical in situations where volunteer board members' availability is limited. Two new modules – one that introduces the key considerations involved with human resources management, and one on strategic planning—have been developed, and the program will be piloted in the upcoming fiscal year. We now have a total of five modules on governance-related topics available for the boards of member museums.

## Special Topic Workshops

In 2015-2016, MAS was able to offer a variety of workshops aimed at mid to advanced-level museum professionals. The number of registrations and the overwhelmingly positive feedback received suggest that these programs met the needs of many of members.

In the fall, a workshop at the Saskatoon Western Development Museum introduced the concepts and equipment needed for a successful digitization project. As well, Beverly Serrell, a Chicago-based exhibit consultant, delivered a seminar on front-end and formative evaluation for exhibit designers at the RCMP Heritage Centre in Regina.

A workshop on Collecting and Using Oral History, facilitated by Emily Burton of Pier 21—the Canadian Museum of Immigration – was held in this fiscal year.

In spring 2015, we also held a Collections in the Community symposium at the Diefenbaker Centre in Saskatoon, in which representatives from member museums presented about programs that engaged community with their collections in a variety of ways. In addition, three student volunteers through the University of Regina's ArtsCARES program reviewed and evaluated the special topics workshop program. Their notes and recommendations will be invaluable as staff schedule and plan revisions for the program in the months ahead.

## Introduction to Art Handling, Storage, and Exhibition

As a result of member requests, we have developed a new program tailored to the needs of new art gallery

employees. This is a one-day workshop designed to familiarize gallery workers with the principles and practices of handling, storing, and displaying art works. The program will be offered for the first time in spring, 2016.

#### Peer Exchange

Our third annual Peer Exchange was held in fall 2015 at the Saskatoon Western Development Museum, and was a great success. Museum professionals presented to their colleagues from around the province about insights and challenges related to their museum work, and had the opportunity to network and benefit from each other's skills and experience. We will continue the Peer Exchange program in 2016.

### Museums and Sustainability Initiative


Sustainability—whether environmental, social, economic, or cultural—is one of the most significant issues facing us today. MAS is doing its best to promote discussion of sustainability, raise awareness about best practices in sustainability, and recognize our members' efforts toward greater sustainability through the Museums and Sustainability Initiative.

This year, efforts have focused on the Museums and Sustainability: Sustainable Collections publication. This publication showcases efforts in and beyond the Saskatchewan museums community in creating sustainable collections, and in using collections to create more sustainable communities. It features stories from a range of museums and related groups around the province. These stories demonstrate some of the many ways our Saskatchewan institutions are helping build communities and collections with innovative, holistic approaches to sustainability and community engagement, with a special emphasis on intangible cultural heritage.

#### **Advisory Services**

Based off of *Standards for Saskatchewan Museums*, Advisory Services assists MAS institutional members with achieving their goals. Advisory consultations can be in the form of telephone calls, emails, referrals, and/or site visits. All consultations are confidential.

In 2015-2016, Advisory Services fielded 117 advisory requests, including 6 site visits. To ensure that members are getting information through various avenues concerning numerous topics the Museums Advisor has been the lead for the MAS Facebook page. Social Media avenues allow Advisory Services to be visible with members as well as provide timely information. Advisory Services also includes the publication of Tip-Sheets; published this year was *How to Label Historic Artifacts*. This year also included the publication of the 5th edition of *Standards for Saskatchewan Museums*; all MAS members received a free hard copy with a digital version also available in the members only section of the MAS website.



### **Resource Library**

The MAS library is a source of information and resources for all aspects of museum work. Containing over 1766 titles, it is full of best practices, case studies, and practical knowledge that can benefit any museum.

The Environmental Monitoring Equipment Loan Program, consisting of Elsec 765C and HOBO U14 monitors, were utilized 3 times by members in 2015-2016. The HOBO U14 monitors and records relative humidity and temperatures while the Elsec 765C monitors and records UV, visible light, relative humidity, and temperature.

The Museums Advisor serves as the focal point of this program as the equipment needs to be set-up before sending to borrowing institutions, making it a relatively simple procedure for them to use once received.

The Oral History Recording Equipment Loan Program consists of either audio kits which include a portable audio recorder, and all the accessories and instructions needed to operate it or video kits which include a video camera, and its accessories and instructions. The PD Coordinator serves as the staff contact for those wishing to borrow this equipment.



## **Collective Voice**

In order to create greater public awareness and understanding of the past, present, and future impact of Saskatchewan's heritage, within the resources available, MAS undertakes a variety of actions directed at different audiences.

During 2015-2016, MAS maintained its investment in multiplatform, paid advertisements; this included ads in: Prairies North magazine & website, Urban Voice, and Leader Post/Star Phoenix (Culture Days, Heritage Week & Volunteer Week). The MAS lease car continued to wear its 'vehicle wrap' where the Association name, logo, website address, and tag line "Treasures for the Mind" creating a traveling ad. This is expected to provide considerable exposure over the course of the 5-year lease agreement as the car travels throughout the province.

MAS also hosted a booth at the SUMA tradeshow. Having a booth at this event enabled MAS to raise the profile of both the Association and our members with the vast majority of urban municipalities in the province.

MAS also continues to focus on its on-line presence. MAS continues to manage its online presence in such a way that those few members who are unable to access electronic communications are not left behind while at the same time meeting the needs of those who have embraced the digital communication. MAS continues to provide key documents by mail such as the Education Calendar, as well as, other occasional publications.

### **Core Communication Tools**

MAS produced *The Megaphone*, with features on member and MAS activities. It is published on MAS' website and emailed to members on an occational basis. Archived copies of *Megaphone* are also located on our website.

*E-Phemera*, MAS's e-newsletter, features timesensitive events and opportunities which are highlights of our website. It is produced and distributed widely via email. Archived copies of *E-Phemera* are also located on our website. MAS Board & Staff Quarterly Report a publication requested by members to inform them of Board and MAS activities, was published and posted to the MAS website. This annual report comprises the fourth quarterly report for the current fiscal year.

MAS website, www.saskmuseums.org, was updated regularly ensuring member information, news and events along with MAS events were made available as quickly as possible.

The MAS Facebook and Twitter accounts are maintained as two ways for MAS to share interesting heritage and museum-related information more widely.

### MAS Annual General Meeting and Conference

MAS held its 2015 AGM and Mini-Conference Government House in Regina May 22nd. This year, in addition to the Member Forum, sessions were presented by representatives from the Canadian Heritage Information Network on Nomenclature, and the Canadian Museum of History on the Virtual Museum of Canada (Community Memories).

### Advocacy

In order to affect positive change on behalf of the museum sector in Saskatchewan MAS occasionally undertakes various activities which fit into the broad definition of advocacy. For MAS, advocacy is, fundamentally, about building positive relationships with decision makers in order to achieve desired goals. This process takes place with several categories of stakeholder including: funders, governments, provincial non-profits and federal non-profits. In some instances this is done because the stakeholder group is the decision maker (governments and funders) and in other cases because the stakeholder group is a potential partner in advocacy, public engagement or capacity development. The other way that MAS is laying the groundwork for future targeted advocacy activities is through a variety activities all focused on increasing public awareness of the role and value of museums in Saskatchewan.

#### **Advocacy Activities**

- Representatives of MAS Board and staff participated in the Canadian Museums Association Annual Conference, April 11th – 14th, 2015; SaskCulture AGM, June 17th, 2015; and Heritage Saskatchewan Forum and AGM, February 23rd and 24th, 2016.
- MAS was represented by the PD Coordinator at the annual Multitype Library Board meeting on April 15th, 2015.
- Representatives of MAS Board and staff participated in the SaskCulture Eligible Organizations consultations June 17th, 2015.
- MAS was represented by the Executive Director at the National Trust Conference and AGM October 21st to 23rd, 2015.
- MAS Executive Director participated in the Canadian Museums Association's 'Canadian Museums Day' on Parliament Hill on January 26th, 2016 meeting with three Parliamentarians to discuss legacy projects including: youth employment in museums, national museum policy and program review and funding stability.
- MAS Executive Director participated in the CMA meeting with representatives of the provincial and territorial museums associations January 25th, 2016 in Ottawa. A significant part of the meeting was a focus group session with staff from the Department of Canadian Heritage to discuss the evaluation of the Museums Assistance Program.
- MAS continues as a member of Heritage Saskatchewan ensuring the Association's contribution on issues relevant to the Saskatchewan museum sector. This included participating in a Municipal Cultural Planning session on February 18th and a Community Cultural Planning Roundtable on February 19th, 2016.

#### Management's Responsibility

The external auditors have full and free access to, and meet periodically and separately with, both the Committee and management to discuss their audit findings.
