COMMUNITY LEADERSHIP

SaskCulture

The Executive Director attended SaskCulture's regular Eligible Cultural Organization meeting in November (virtually) where participants could share concerns and opportunities presented by the pandemic. It was noted that 2020 was a record year for lottery sales and that the first half of 2021 also showed very good sales numbers. This is important because it ensures stable funding through Saskatchewan Lotteries Trust to both MAS and those members accessing SK Lotteries funding through other programs most notably the MGP.

In other SaskCulture news applications for the full MGP were accepted until the grant deadline of December 1, 2021. Any questions regarding the MGP should be directed to Catherine Folstad at SaskCulture: <u>cfolstad@saskculture.</u> <u>ca</u>

The MAS ED met, virtually, with Dennis Garrick, SaskCulture Outreach Consultant, to provide him with an update on MAS programs and activities. This is a regular activity and part of the operational funding process SaskCulture administers on behalf of Saskatchewan Lotteries Trust.

CMA & PTMAs

The ED has continued to be involved in activities at the national level during this reporting period. This has taken the form of meetings with the colleagues from the other Provincial/Territorial Museums Associations. An important topic of discussion was the CMA Reconciliation project. This project is in answer to the TRC Call to Action #67:

"We call upon the federal government to provide funding to the Canadian Museums Association to undertake, in collaboration with Aboriginal peoples, a national review of museum policies and best practices to determine the level of compliance with the United Nations Declaration on the Rights of Indigenous Peoples and to make recommendations."

This has been a multiyear project which will be concluding in 2022 with a report and 'toolkit' which we look forward to seeing on the new year.

Museums for Me Consortium

This is a national project to determine the value and meaning of museums to Canadians. This multi-year research-based project is led by the AMA and is expected to result in a much better understanding of what museums mean to the public which will assist in advocacy activities at all levels. MAS participates on the steering committee and will assist in promoting project surveys and facilitating focus group sessions during the research phase. Networks

Most the fall Network Zoom meetings was held virtually in October. MAS staff were in attendance along with a Board member. As well, we hosted the first Ecomuseum Network and the first Galleries Network meetings this quarter. National Trust -Heritage Reset Project

The National Trust for Canada, is undertaking this multi-year project which is looking at better understanding the connection between Canadians and Heritage Places (historic sites, landscapes, traditional landscapes). The finding of their national survey was recently produced and will be give insights into who the current and potential 'audiences' for heritage places are and how to better engage with them. MAS has been supporter of this the project since its inception.

These two projects are running parallel and will both provide valuable resources to the Saskatchewan museum sector.

CAPACITY DEVELOPMENT

Courses and Workshops

Two Certificate Program Courses were successfully held during this fall – **Museums and Community** and **Marketing the Museum**. both were offered online – one on our regular online platform and one as a 2-day ZOOM class.

As well, MAS offered three Special Topics workshops, virtually, this quarter:

Introduction to Digitization, in partnership with CCI – Instructor Ern Biemann,

Art Handling – Instructor Edith Skeard,

Rethinking Prairie Histories, in partnership with SCR Districts – Instructor Dr. Sheelah McLean

The Introduction to Digitization webinar series was offered in partnership with the Canadian Conservation Institute. It took place over three sessions on November 8, 15, and 22. Participants examined topics such as flatbed scanning, the long-term preservation of digital images, scanning workflow, identifying and resolving common scanning problems, analog and electronic audio and video media, basic concepts for digital audio and video formats, recording specifications, and preservation formats.

We also offered an Introduction to Art Handling and Storage webinar on October 14 and 15. It introduced gallery staff and volunteers to best practices in handling and displaying artwork, ensuring that artwork is stored safely and accessibly, and conservation considerations in art exhibitions.

The Rethinking Prairie Histories online session was offered in partnership with the Districts for Sport, Culture, and Recreation on November 19. In this session, participants examined the stories they are told about the history of the prairies and how those stories shape their worldview and understanding of inequality. Participants investigated their own social locations within this history and discussed strategies for creating solidarity and allyship across between people with different cultures, histories, and experiences

Heritage Symposium

MAS partnered with Heritage Saskatchewan to hold the Getting Real About Reconciliation Symposium 2nd and 3rd.

- The keynote facilitated discussion was between Chief Cadman Delorme (Cowessess First Nation), Dr Cody Groat (Western University), and Dr Gerald Pocius (Cape Breton University).

- Covid-19 Culture: A Living Heritage Project about the Pandemic in Saskatchewan moderated discussion with 3 project participants.

Advocacy

The ED participated in a meeting November 30th with the other provincial/territorial museums associations (PTMAs) to discuss how best to implement an advocacy strategy with a new Minister of Canadian Heritage. There was also discussion of the status of the CMA Reconciliation project.

The CMA/PTMAs Executive Directors were invited to a meeting with the Department of Canadian Heritage to hear the results of their recently completed Arts and Heritage Access and Availability public survey. This survey is conducted every 3-5 years to track Canadian's attitudes, values and behaviours associated with arts and heritage. "The survey measures overall arts and culture attendance in Canada and the average Canadian's recognition of the arts. Results of this survey also enable the Department to ensure its programs continue to respond to and report on the behaviours and preferences of Canadians. As well, the Department's programs are operating in a context in which new technology and developing platforms, the COVID-19 pandemic, and the responsibility to promote an inclusive society, are key drivers.

Now, when the world is undergoing the global effects of the COVID-19 pandemic, it is especially important to assess shifting attitudes and behaviours which affect the arts sector." The full report can be found here: <u>https://bit.ly/POR_101-</u> 20
